SUPPLY CHAIN VALLEY CONTRIBUTION FEE

The membership fee at Supply Chain Valley classifies two categories of members:

- **Companies, organisations and institutions**
- **Individual members and/or self-employed people**

If you join in the course of calendar year, the contribution will be calculated over the remaining number of months for that year.

For the first category, the amount of the contribution to be paid is determined by the total number of permanent full-time equivalents (FTE) of the relevant company, organisation or institution. This will be based on the workforce of all entities located in the Netherlands.

For the second category, the contribution is a fixed amount per year, with no distinction being made between individual members or self-employed people. Students and people who have reached state pension age receive a 50% discount on individual membership.

Cancelling your membership

At Supply Chain Valley, the financial year coincides with the calendar year, i.e. from 1 January to 31 December. The SCV Articles of Association prescribe that cancellation of SCV membership must be effected in writing or by e-mail, three months before the new financial year.

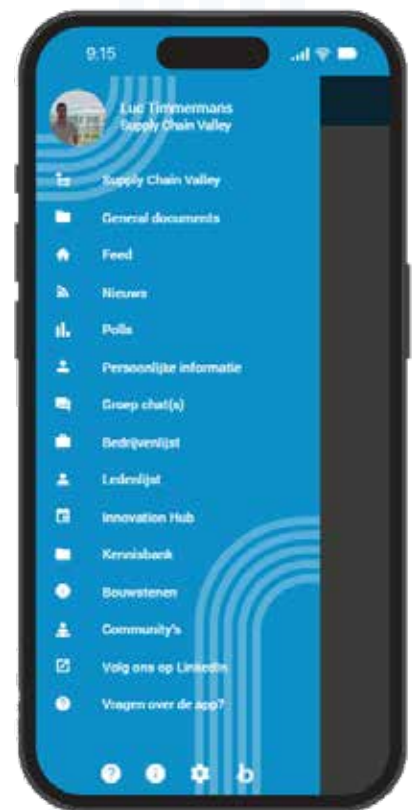
1. Access to a large logistics and supply chain network in Limburg, East Brabant and the Limburg Euregio border area.
